MEMBERSHIP DEFINITONS

HOUSEHOLD (HH)- Those living in the same primary residential household (residency proof required) or those with legal guardianship. Excludes boarding houses, apartments/room rentals and like businesses.

RESIDENT - Individual who lives within the Cuyahoga Falls city limits. Proof of residency (driver's license or utility bill) is required.

SENIOR– 60 years of age and older. Senior pass will not extend beyond 2 people; adding significant other.

SILVER LAKE RESIDENT- Anyone who resides in Silver Lake, Ohio is eligible for the Cuyahoga Falls annual membership rates. <u>Monthly pass discounts do not apply.</u> Proof of residency is required.

BUSINESS – Individuals who work part time or full time for a company in Cuyahoga Falls. Business owners who file city income tax annually/own property in Cuyahoga Falls. Pay stub/tax forms are required. Monthly discounts do not apply.

NON- RESIDENT - Individuals who do not live or work within the city limits of Cuyahoga Falls.

MILITARY – Individual who is Active Duty/Active Reserve or Veteran. Proof required at time of purchase.

DISABILITY— An individual who is on disability and has Social Security Disability Insurance (SSDI), or Supplemental Security Income (SSI). Proof is required at time of purchase.

MINOR- 17 years of age and younger. Proof of residency required. A legal guardian must sign for membership.

KIDS CASTLE– Free for children ages 1 (walking) -9. <u>Guardian(s) have an active annual pass</u> or <u>children</u> with an active annual/monthly/daily pass.
